

The Iowa County Board of Supervisors met on September 12, 2025. Heitshusen, Chairman called the meeting to order at 9:00 a.m. Heitshusen, Meyer, Degen, Montross and Maas were present.

Motion by Montross, seconded by Maas to **approve** the agenda. All aye, motion carried.

Motion by Degen, seconded by Montross to **approve** the minutes for September 5, 2025. All aye, motion carried.

Chair Notes: The board approved handwritten claims paid with warrant numbers 41626-41629. The board approved payroll paid with warrant numbers 41630-41794.

Motion by Maas, seconded by Degen to **approve and authorize chairman to sign** the National Opioids Secondary Manufacturers Settlements Agreement to Participate. All aye, motion carried.

Motion by Degen, seconded by Meyer to **approve Resolution 2025-09-12** between Central Iowa Juvenile Detention Center and Iowa County as follows:

WHEREAS Iowa County is a stakeholder in the Central Iowa Juvenile Detention Center (hereinafter CIJDC), and

WHEREAS the CIJDC is the Respondent in Hardin County Case No. CVCV102247, whereby Hardin County calls into question the validity of prior 28E agreements, and

WHEREAS the outcome of that litigation is uncertain, and Iowa County has an interest in the outcome of that litigation, and

WHEREAS the CIJDS Commission has voted 22-5 to approve the attached compromise settlement agreement resolving the litigation, and

WHEREAS the compromise settlement agreement is a compromise between Hardin County and the CIJDC that acknowledges the membership of counties joining the CIJDC through 2012 and also allows the remaining counties to maintain certain benefits that the litigation does not otherwise guarantee, while also allowing the counties joining through 2012 to adopt a new 28E agreement and even vote to allow the remaining counties to regain full membership in the CIJDC, and

WHEREAS the Parties will file with the Court a consent decree memorializing the full terms and conditions of the Parties' compromise settlement agreement following approval of the compromise settlement by a majority of the member counties.

THEREFORE, the Iowa County Board of Supervisors hereby approve and adopt the attached compromise agreement and authorize the CIJDC to execute and present to the court a consent decree consistent with the attached compromise settlement. Roll call vote: Meyer – yes, Maas - yes, Montross – yes, Degen – yes, and Heitshusen – yes. Motion carried.

Motion by Maas, seconded by Montross to **approve the Certificate of Adjustment** of Tax List Item for parcel #730405010. All aye, motion carried.
