Motion by Montross, seconded by Maas to **approve the agenda**. All aye, motion carried.

Motion by Maas, seconded by Meyer to **approve the minutes** from February 27, 2026. All aye, motion carried.

Motion by Montross, seconded by Meyer to **pass, adopt and approve Resolution 2026-03-06 – REIC of Iowa County Agreement** as follows:

**Resolution 2026-03-06**

WHEREAS, the county of Iowa County, Iowa is a member of the Regional Environmental Improvement Commission of Iowa County, Iowa, as organized under Iowa Code Chapter 28E(Commission); and

WHEREAS, the Regional Environmental Improvement Commission of Iowa County, Iowa was created to continuously study and implement methods and means to efficiently, economically, and lawfully manage solid waste generated by members of the Sanitary Landfill Joint Agreement dated May 4, 1971; and

WHEREAS, the Commission desires to amend the 2023 Iowa Regional Environmental Improvement Commission of Iowa County, Iowa Articles of Agreement dated December 13, 2023 to explicitly require waste generated or collected within a Member jurisdiction be delivered to and deposited in the Iowa County Landfill located in Homestead, Iowa; and

WHEREAS, the Commission desires to amend the 2023 Iowa Regional Improvement Commission of Iowa County, Iowa Articles of Agreement dated December 13, 2023 to state the Commission will choose a mediator for the resolution of disputes among members and disputes with Court involvement will be held in Iowa County, Iowa; and

WHEREAS, the Commission desires to amend the 2023 Iowa Regional Environmental Improvement Commission of Iowa County, Iowa Articles of Agreement dated December 13, 2023 to state the commission will manage , enforce, defend, and prosecute any Iowa County

Flow Control Ordinances, or and ordinances of a similar nature pertaining to the control c of waste generated in Iowa County, Iowa; and

WHEREAS, the proposed 2026 Iowa Regional Improvement Commission of Iowa County, Iowa Articles of Agreement dated January 21, 2026 has been prepared which document includes the proposed amendments; and

WHEREAS, the requisite vote by Commissioners has taken place to amend the previous agreement dated December 13, 2023 and adopt the proposed 2026 Iowa Regional Environmental Improvement Commission of Iowa County, Iowa Articles of Agreement dated January 21, 2026;

WHEREAS, amendments to the 28E Agreement for the Commission require approval by two-thirds vote of all possible votes of the Commissioners followed by the approval of same by Resolution of two-thirds of Member municipalities; and

NOW, THEREFORE, BE IT RESOLVED, pursuant to the provisions of Chapter 28E, Code of Iowa, the county of Iowa County, Iowa hereby approves that the 2023 Iowa Regional Environmental Improvement Commission of Iowa County, Iowa Articles of Agreement dated December 13, 2023 be omitted in its entirety to be amended in its entirety with the 2023 Iowa Regional Environmental Improvement Commission of Iowa County, Iowa Articles of Agreement dated January 21, 2026.
